No. PMA.627/2010/436 : In exercise of the powers conferred by section-38 of the Right of Children to Free and Compulsory Education Act, 2009, (Act No. 35 of 2009), the Governor of Assam is hereby pleased to make the following rules, further to amend the Assam Right of Children to Free and Compulsory Education Rules, 2011 hereinafter referred to as the Principal Rules namely:-

- Short title and commencement : 1. (1) These rules may be called the Assam Right of Children to Free and Compulsory Education (Amendment), Rules, 2017.  
(2) They shall come into force on the date of their Publication in the official Gazette.
- Amendment of Rule 22 2. In the Principal Rules, in rule 22,-  
(1) in sub-rule 2, in clause (c), for the existing provision the following shall be substituted, namely:-  
“(c) prepare class-wise, subject-wise learning outcomes for all elementary classes ; and”  
(2) after clause (c), a new clause (d) shall be inserted, namely:-  
“(d) prepare guidelines for putting into practice continuous and comprehensive evaluation to achieve the defined learning outcomes.”


