# RASHTRIYA BAL SWASTHYA KARYAKRAM (RBSK)

## Objective of Scheme

Rashtriya Bal Swasthya Karyakram (RBSK) is aimed at early identification and early intervention for children from birth to 18 years to cover 4 'D's viz. Defects at birth, Deficiencies, Diseases, Development delays including disability

## Target Beneficiaries

The services aim to cover all children of 0-6 years of age group in rural areas and urban slums, in addition to older children upto 18 years of age enrolled in classes 1st to 12th in Government and Government aided schools

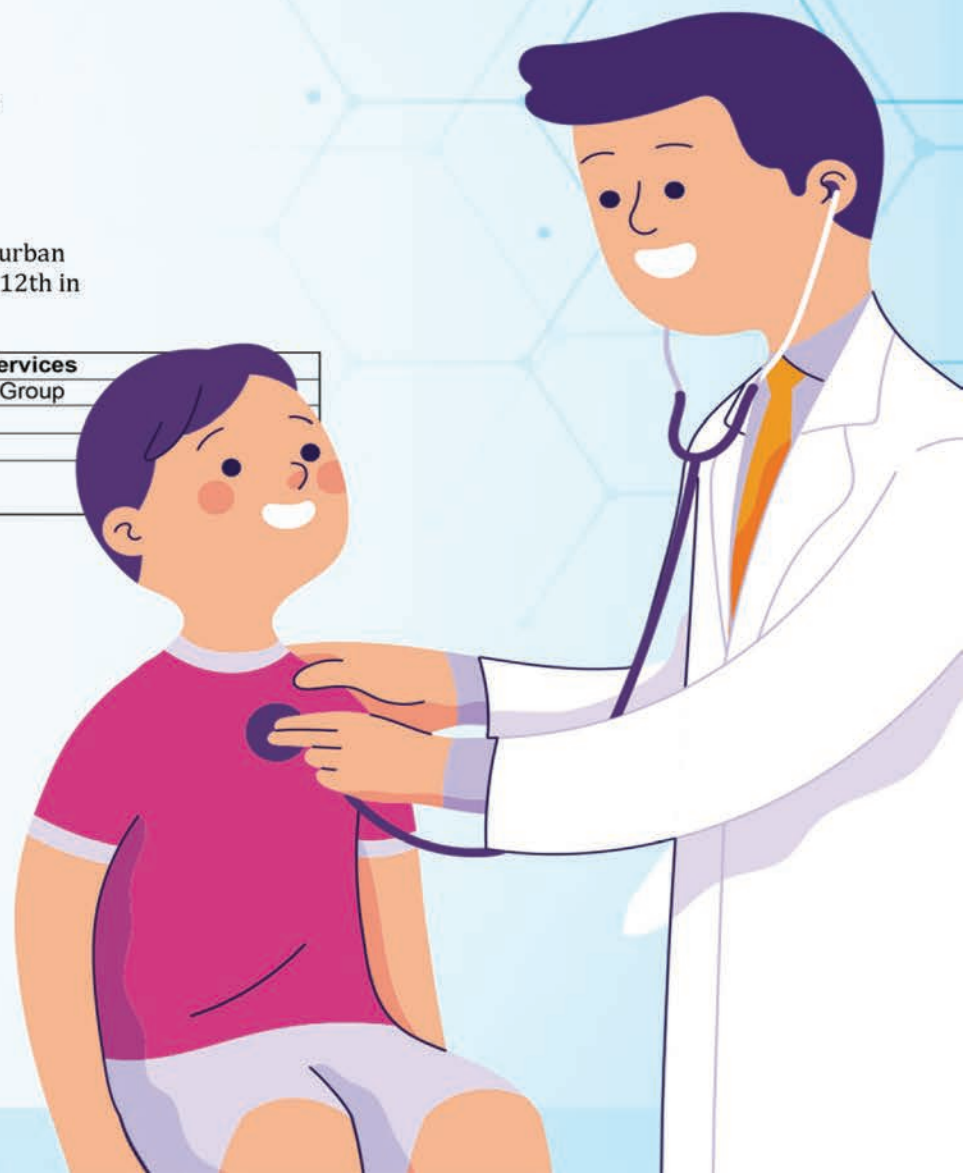
Target Group under Child Health Screening and Intervention Services	
Categories	Age Group
Babies born at public health facilities and home	Birth to 6 weeks
Preschool children in Anganwadi Center (AWC)	6 weeks to 6 years
Children enrolled in classes 1st to 12th in Government and Government aided schools	6 to 18 years

## Provisions under scheme / entitlements

Early Intervention Services under RBSK would cover the following health conditions for Screening, early detection and free management

**Defects at Birth** - Neural tube defect, Down's Syndrome, Cleft Lip & Palate / Cleft palate alone, Developmental dysplasia of the hip, Congenital cataract, Congenital deafness, Congenital heart diseases, Retinopathy of Prematurity, Microcephaly

**Deficiencies** - Anaemia especially severe anaemia, Vitamin A Deficiency (Bitot's spot), Vitamin D Deficiency (Rickets), Severe acute malnutrition, Goiter, Severe stunting, Vitamin B complex def





### Provisions under scheme / entitlements

**Diseases of Childhood** - Skin conditions (Scabies, fungal infection and Exzema), Otitis Media, Rheumatic heart disease, Reactive airway disease, Dental caries, convulsive disorders, Childhood T.B., Childhood Leprosy, Childhood extra pulmonary T.B.

**Developmental delays and Disabilities** - Vision Impairment, Hearing impairment, Neuro-motor impairment, motor delay, cognitive delay, Language delay, Behaviour disorder (Autism), Learning disorder, Attention deficit hyperactivity disorder

**Other** – Congenital Hypothyroidism, Sickle Cell Anemia, Beta Thalassemia (Optional)

**Adolescent Health Concerns** – Growing up concerns, Substance abuse, Feel depressed, Delay in menstruation cycles, Regular periods, Experience any pain or burning sensation while urinating, Discharge / foul smelling discharge from the genitor – urinary area, pain during menstruation

The Mobile Health Team (MHT) visits the schools and Anganwadi centres (AWC) for screening regularly. MHT visits twice a year to AWCs and once in a year in schools. After the screening the detected children are referred to the District Early Intervention Center (DEIC) / District Hospital or sometime to the empanelled tertiary level hospitals for better treatment as per disease criteria under RBSK programme

# RASHTRIYA KISHOR SWASTHYA KARYAKRAM (RKSK)

## Objective of Scheme

- Enable adolescents to realize their full potential by making informed and responsible decisions related to their health and wellbeing
- Conduct health promotion and community-based programmes on improved nutrition, enable sexual & reproductive health, prevent injuries and violence (including gender based violence), address condition for non-communicable diseases, enhance mental health and prevent substance misuse.

## Target Beneficiaries

Adolescents in the age group of 10-14 years and 15-19 years with universal coverage, i.e. males and females; urban and rural; in school and out of school; married and unmarried; and vulnerable and under-served.

## Provisions under scheme / entitlements

The RKSK has the following components to address adolescent health:

**Adolescent Health Day (AHD)** - AHD will be organized in every village once every quarter following the VHND. During AHD, the following services provide:

- Information: IEC and IPC on Nutrition, SRH, Mental Health, GBV, NCD, Substance misuse
- Commodities: Sanitary Napkins, IFA, Albendazole, anti-spasmodic tablets and contraceptives
- Services: Registration, general health check-up, (BMI, anaemia ,hypertension and diabetes), Referral to AFHCs (for counselling and clinical services)





### Provisions under scheme / entitlements

**Peer Educator (PE)** - The PE programme aims to ensure that adolescents or young people between the ages of 10-19 years benefit from regular and sustained peer education covering nutrition, sexual and reproductive health, conditions for NCDs, substance misuse, injuries and violence (including GBV) and mental health. Each Peer educator would – Form a group of 15- 20 boys and girls respectively from their community and conduct weekly one to two hour participatory sessions using PE kits

**Adolescent Friendly Health Clinics** – Through Adolescent Friendly Health Clinics (AFHCs), counselling and curative services are provided at primary, secondary and tertiary levels of care on fixed days and fixed time with due referral linkages. Commodities such as Iron & Folic Acid tablets and non-clinical contraceptives are also made available in the clinics for the adolescents. Commodities to be available at AFHCs are – WIFS & Albendazole, sanitary napkins, Contraceptives, Medicines

Counseling on nutrition, menstrual disorders, personal hygiene, menstrual hygiene, use of sanitary napkins, use of contraceptives, sexual concerns, depression, sexual abuse, gender violence, substance misuse and promoting healthy behavior to prevent non communicable diseases

# WEEKLY IRON & FOLIC ACID SUPPLEMENTATION PROGRAMME (WIFS)

## Objective of Scheme

The Ministry of Health and Family Welfare, Government of India has launched the Weekly Iron and Folic Acid Supplementation (WIFS) Programme to reduce the prevalence and severity of nutritional anaemia in adolescent population (10-19 years)

## Target Beneficiaries

Weekly Iron and Folic Acid supplementation programme will be planned and implemented for the following two target groups in both rural and urban areas:

- Adolescent girls and boys enrolled in government/government aided /municipal schools from 6th to 12th classes
- Adolescent Girls who are not in school





### **Provisions under scheme / entitlements**

IFA supplements are distributed free of cost on a weekly basis to adolescents. In addition to IFA supplements, Albendazole tablets for deworming are administered twice a year to the same target group

# MENSTRUAL HYGIENE SCHEME (MHS)

## Objective of Scheme

Promotion of menstrual hygiene among adolescent (10-19 years) girls in rural areas as part of the Adolescent Reproductive Sexual Health (ARSH) in Reproductive Child Health programme with specific reference to ensuring health for adolescent girls.

The objectives are to:

- To increase awareness among adolescent girls on menstrual hygiene.
- To increase to and use of high quality sanitary napkins to adolescent girls in rural areas.
- To ensure safe disposal of sanitary napkins in an environment friendly manner.

## Target Beneficiaries

All adolescent girls

## Provisions under scheme / entitlements

A pack of 6 sanitary napkins are provided to adolescent girls in rural areas under the brand 'Freedays' by NHM. Napkins are sold to the adolescent girls at Rs 6 per pack of 6 napkins in the village by the ASHA.

# SNEHA SPARSHA

## Objective of Scheme

Sneha Sparsha aims at bearing expenditure of very high-end specialized treatment such as Thalassemia requiring Bone Marrow Transplant, Liver and Kidney transplant, and Cochlear Implant for children below 14 years

## Target Beneficiaries

All Children below 14 years of age will be entitled to get benefits under this scheme with annual income less than Rs 5 (five) lakhs per annum. However, in exceptional cases the income limit may be relaxed after due consideration at the highest level

## Provisions under scheme / entitlements

**Treatment for following diseases are admissible under Snehasparsha Scheme**

Bone Marrow Transplant (Children with Leukeumia (Blood Cancer) and other conditions like Thalassemia), Cochlear implant, Liver transplant, Kidney Transplant, Artificial Limbs, Blood Cancer, Specialized Eye Surgery, Tumors, Neurological Anomalies, Thalassemia, Cerebral Palsy and other neurological disorders

# **CHD**

## **(Conginatal Heart Disease)**

### **Objective of Scheme**

Free Treatment for economically weak children having Congenital Heart Disease (CHD)

### **Target Beneficiaries**

Children of (0-18) years of age group diagnosed with Congenital Heart Disease can be applicant. The guardian of the applicant must be permanent residents of Assam and income should not exceed Rs 6 lakh. The family of the applicant should have Prime Minister Jana Arogya Yojana / Atal Amrit Abhiyan Card





### **Provisions under scheme / entitlements**

The Govt will bear the expenses of surgery for children who have been recommended surgery for congenital heart disease. The govt. will also bear the air fare from Guwahati, of the child and one guardian to and from the designated referral Hospital, besides providing adequate accommodation facility in or, close to the hospital for the guardian during the hospitalization period of the child

# NATIONAL PROGRAMME FOR PREVENTION AND CONTROL OF DEAFNESS (NPPCD)

## Objective of Scheme

To prevent and control major causes of hearing impairment and deafness, so as to reduce the total disease burden

## Target Beneficiaries

All Citizens

## Provisions under scheme / entitlements

### Early Detection -

- House to house surveys will be conducted by the AWWs & ASHAs, under the supervision of the male and female MPWs for detection of cases of hearing impairment and deafness
- School teachers will undertake to screen the children in the school to identify children with any ear or hearing problem. They will then be referred to the School Health doctor for evaluation, diagnosis and guidance regarding treatment

### Ear screening camps-

Screening camps will be organized in collaboration with NRHM (RBSK)/ M/o SJ&E at the PHC/CHC and District level for screening the general population in respect of ear problems, hearing impairment and deafness





## Provisions under scheme / entitlements

### Treatment:

- Treatment of all affected persons would be undertaken at the following levels:
- Public Health Nurses and MPWs: would provide treatment of common ear ailments under the guidance of the PHC doctor.
- Trained PHC/CHC doctors will provide early diagnosis of ear diseases and treatment of all common ear ailments. All persons requiring special diagnostic facilities, complicated cases and those needing surgical intervention will be referred to the District hospital.

### Rehabilitative services:

- All patients who are identified as having an ear problem that either requires surgery, hearing aid fitting or rehabilitative therapy will be referred to the ENT doctor and Audiologist at the district level.
- Those who need surgery will be given the appropriate treatment at the district hospital.
- Complicated cases that cannot be adequately handled at the District hospital will be further referred to the State Medical College for expert treatment

# SCHOOL HEALTH & WELLNESS PROGRAMME (SHWP)

## Objective of Scheme

School Health & Wellness Programme (SHWP) under Ayushman Bharat is a joint initiative of Ministries of H&FW and Ministry of Education. In Assam SHWP is implemented in 7 aspirational Districts namely Baksa, Barpeta, Darrang, Dhubri, Goalpara, Hilakandi and Udalguri. In the FY 2022-23 the new districts are Jorhat, Charaideo and Kokrajhar to be covered. Objectives of the scheme are as follows:

- To provide age appropriate information about health and nutrition to the children in schools.
- To promote healthy behaviors among the children that they will inculcate for life.
- To detect and treat diseases early in children and adolescents including identification of malnourished and anemic children with appropriate referrals to PHCs and hospitals.
- To promote use of safe drinking water in schools.
- To promote safe menstrual hygiene practices by girls.
- To promote yoga and meditation through Health & Wellness Ambassadors.
- To encourage research on health, wellness and nutrition for children.

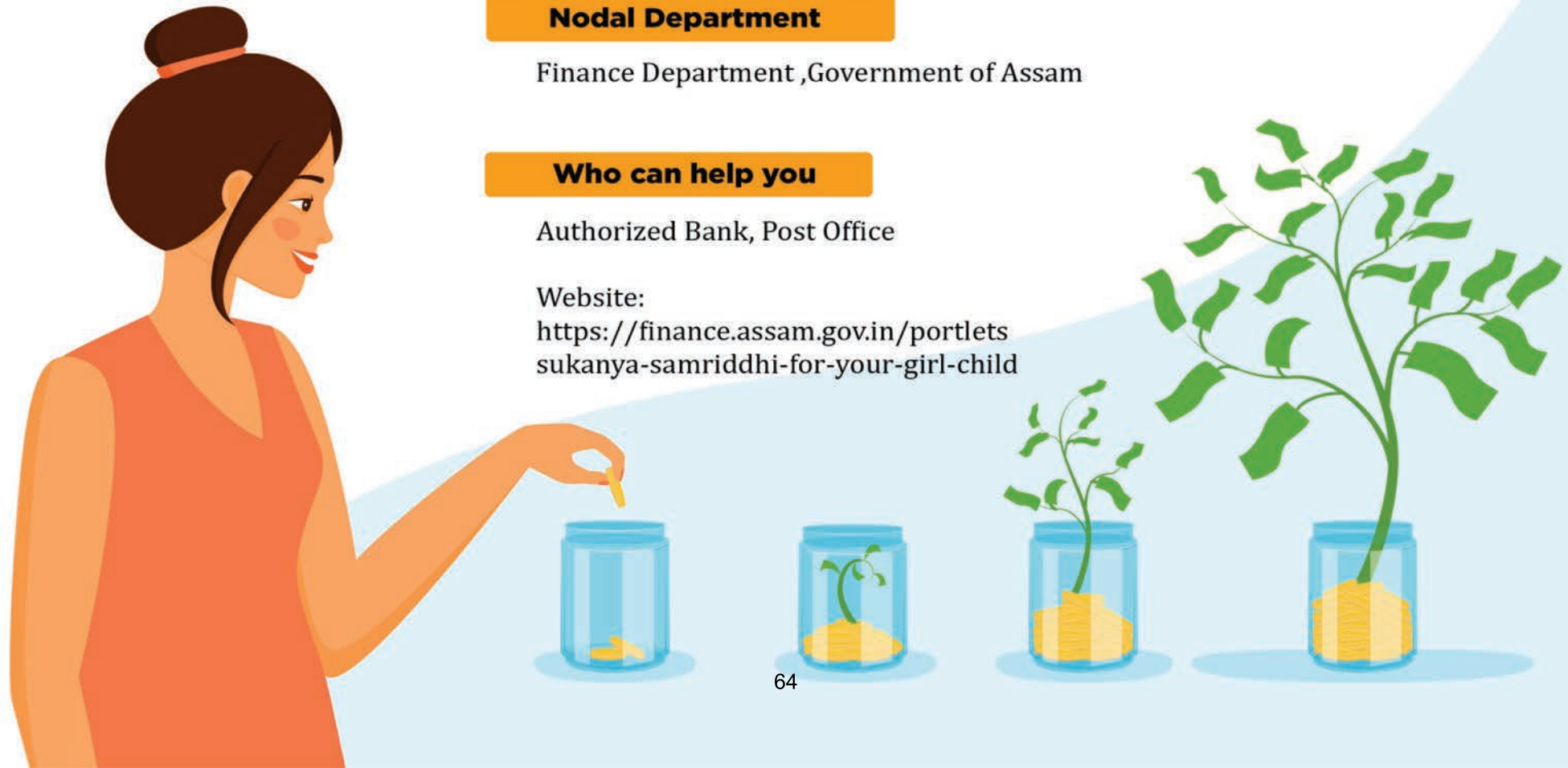

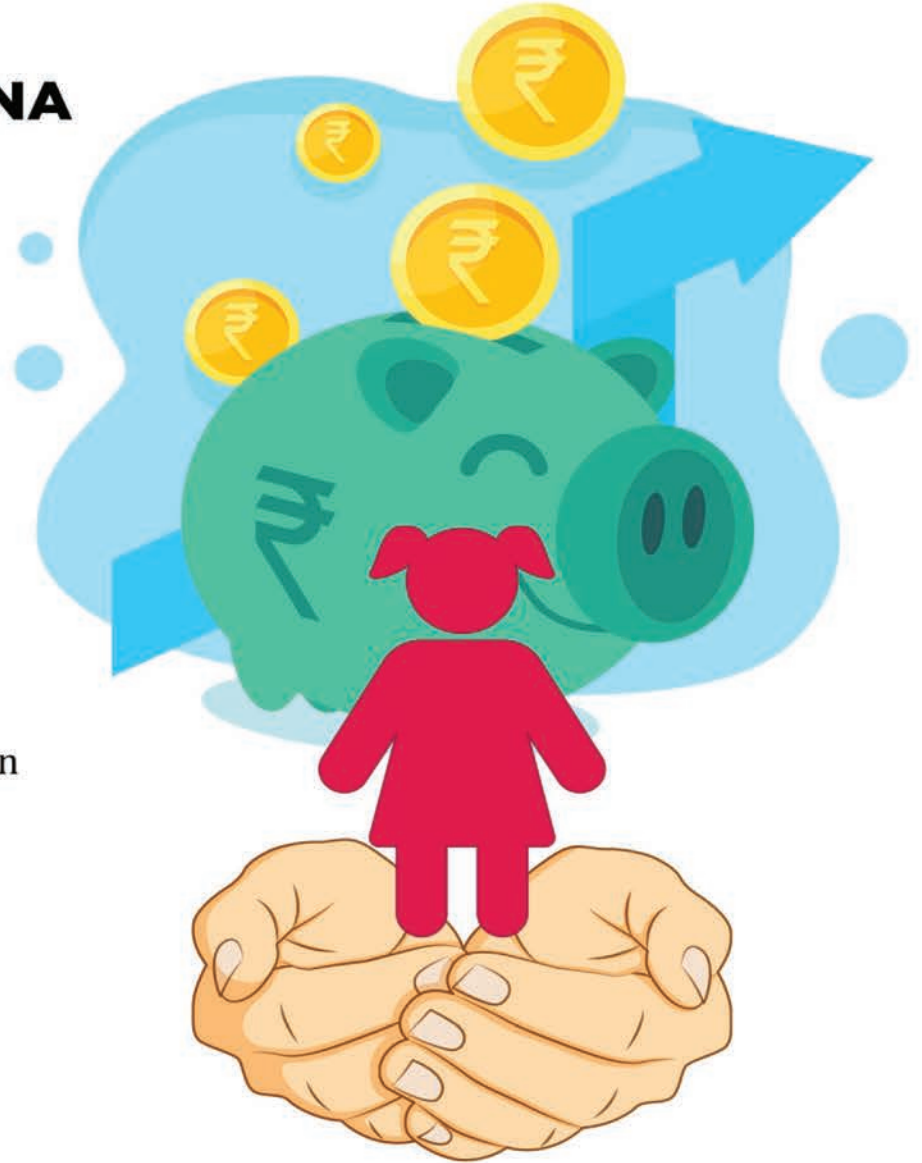
# SUKANYA SAMRIDDHI YOJANA

## Objective of Scheme

To ensure equitable share to a girl child in resources and savings of a family by encouraging small deposit investment assuring high interest rate and tax benefit under 80C of Income tax Act. The is launched as part of the Beti Bachao Beti Padhao' programme

## Target Beneficiaries

- Parents or legal guardians of a girl child can open an SSY account
- Girl child has to be below the age of 10 at the time of opening SSY account



# SCHEME FOR ADOLESCENT GIRLS (SAG)

## Objective of Scheme

- Facilitate, educate and empower out of school adolescent girls
- Create awareness on health, hygiene, nutrition among out of school adolescent girls
- Improve the nutrition and health status of school adolescent girls
- Support out of school adolescent girls to successfully transition back to formal schooling or provide them with vocational training
- Provide information and guidance about existing public services

## Target Beneficiaries

Adolescent girls in the age group of 11-14 years who are out of school

# WOMEN HELPLINE 181

## Objective of Scheme

Provide toll-free 24-hours telecom service to women affected by violence seeking support and information

Facilitate crisis and non-crisis intervention through referral to the appropriate agencies  
Provide information about the appropriate support services, government schemes and programmes available to the woman affected by violence

## Target Beneficiaries

Any woman or girl facing violence within public or private sphere of life or seeking information about women related programmes or schemes



## Provisions under scheme / entitlements

As soon as an aggrieved woman (AG) or somebody on her behalf will contact WHL, her information would be attended by the call responder appointed there. Based on the urgency and the requirements explained by the caller, the responder will refer her to relevant support services like medical aid, police assistance or connect her to OSC for professional counselling, shelter, legal aid etc; if the woman needs to be rescued from a violent situation or is in urgent need of medical assistance then the PCR Van from the nearest police station or ambulance from nearest hospital/ 108 service would be dispatched

Women Helpline (WHL) will provide information about the laws, existing schemes and government programs related to women empowerment and protection. Any woman in need of such information or someone on her behalf may call WHL which will provide this information or refer the woman to the relevant department to access the same. WHL will also provide guidance to women about processes to be adopted for accessing benefits of these schemes and programs

Facilitate immediate, emergency and non-emergency access to a range of services including medical, legal, psychological and counseling support under one roof to fight against any forms of violence against women

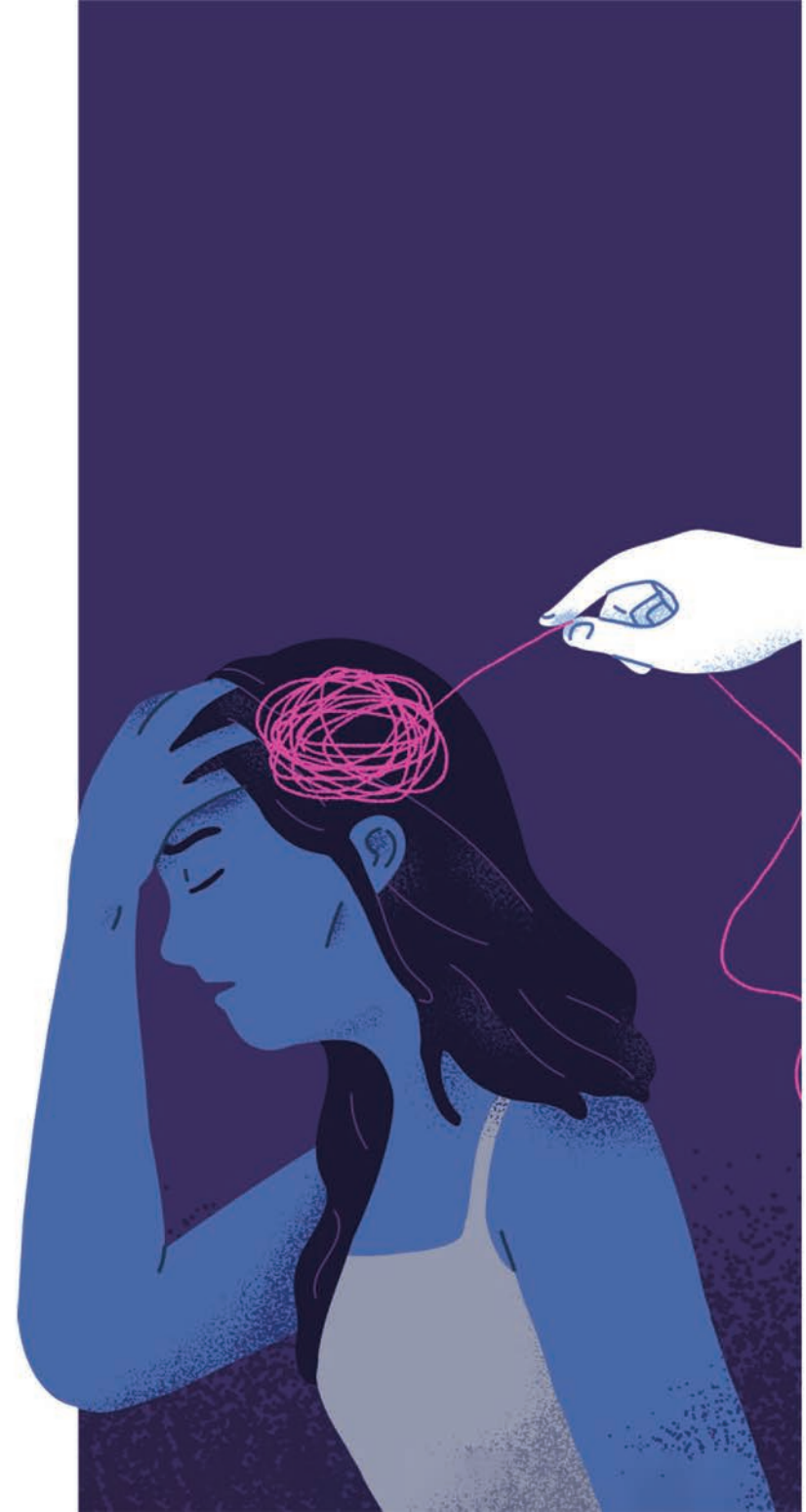

# CHILDLINE 1098



## Objective of Scheme

CHILDLINE is a National, 24 Hour, Emergency toll free phone service for children in need of care and protection. Along with response to the emergency needs of children CHILDLINE also links them to relevant services for their long-term care and rehabilitation covering the following child issues: Child Labour, Abuse and Violence ,Sexual Abuse , Child Trafficking , Missing , Runaways, Child Health , Addiction , Education Related, Child Marriage , Conflict with the law, Homeless.

All children below 18 years

## Provisions under scheme / entitlements

CHILDLINE 1098 is a national emergency toll free phone service for children. When any child is in any distress, any child or a concerned adult can dial the CHILDLINE 1098 helpline, which operates 24 hours (night and day). The call is received by the CHILDLINE centre where details about the situation are taken by the caller and CHILDLINE units are mobilized if necessary. Once, CHILDLINE has enough details about child or children in distress, the CHILDLINE team rushes to help children within 60 minutes to bring children out of an emergency situation. Once CHILDLINE officials help the child, it works with multiple stakeholders such as police authorities, child protection boards, social workers and counselors. Children's consent and participation is an important component of this process from response to intervention. After the interventions, to ensure the child's continued safety, CHILDLINE proceeds to find long-term rehabilitation for the child. For this, the CHILDLINE team does constant follow ups with the child – meeting the family or the visiting the shelter.
