No. E-334916/ : In exercise of the powers conferred under section 21 of the Right of Children to Free and Compulsory Education Act,2009, the Governor of Assam is pleased to re-constitute the School Management Committee of Govt./Provincialised Elementary schools of Assam as per Part V of Rule 13 of the Assam Right of Children to Free and Compulsory Education Rules, 2011 in the following manner:

13. (1) Composition of the School Management Committee for the purposes of section 21 :-

- i. A School Management Committee shall be formed for each school. This would be a permanent Bod y of which, the President and Members shall have a term of three years. However, the y shall continue to function beyond three years till the new President and Members take over. Efforts should be made to form the new Committee one month before the expiry of the term of the outgoing Committee.
- ii. Twelve members shall be from parents/or Guardians of the students of the School in the following manner :
 - a. Among parent/guardian members, six shall be from disadvantaged groups or weaker section and one of them shall be from parent/guardians of children with Special Needs (if any) in the school,"
 - b. President and Vice Presiden t shall be selected/elected from the parents/guardians member only and one of them must be a woman;
 - c. No parent/guardian can be the President or Vice-President of more than one School Management Committee irrespective of the fact that his/her children study in more than one school.
- iii. One elected member from PRI, VCDC in case of 6th Scheduled areas and Urban local from the area where the school is located.
- iv. One member shall be from among teachers of the school.
- v. Two members are to be nominated by the Alumni Association of the school.
- vi. Head Teacher/Head Master shall be Member-Secretary.
- vii. Minimum fifty percent of the above committee members shall be women.

The powers and functions etc. of School Management Committee will remain same as per earlier Notification No. PMA.627/2010/Pt/149 dated 03/08/2011.
