In pursuance of the provisions of the Assam Right of Children to Free and Compulsory Education Rules, 2011, the Governor of Assam is hereby pleased to notify the following:

- 1. In pursuance of section 2(d), of the Right of Children to Free and Compulsory Education Act, 2009, Govt. of Assam is pleased to notify that the "Child belonging to Disadvantaged Group" will include the Children(within the age group of 6-14 years) belonging to:
 - a. Scheduled Caste
 - b. Scheduled Tribe
 - c. Children With Special Needs(CWSN)
 - d. Orphan
 - e. Migrant and Street Children
 - f. HIV affected/Infected Children
- 2. In pursuance of section 2(e), of the Right of Children to Free and Compulsory Education Act, 2009, Govt. of Assam is pleased to notify that the "Child belonging to Weaker Section" will include the Children (within the age group of 6-14 years) of the families belonging to BPL category.
- 3. For identification of orphan, children with Special Needs (CWSN) and HIV affected/Infected Children, certificate of competent authority of State Social Welfare Department and Health Department will be relied upon.
- For identification of children belonging to SC/ST category, the certificate issued by the competent authority as notified by Govt. of Assam will be relied upon.
- 5. For identification of Migrant and Street Children, certificate of Labour Department or local police station will be relied upon.
- 6. For identification of Child belonging to Weaker Section, Parents or Guardians, certificate of competent authority of State Revenue Department will be relied upon.
- 7. This order will come into force with immediate effect.
