ORDERS BY THE GOVERNOR OF ASSAM

NOTIFICATION

Dated Dispur, the 29th April, 2011

No. AEE 499/2010/17: The Governor of Assam is pleased to notify the following guideline for conducting Evaluation in elementary stage of Class I to VIII in the state of Assam. This is in consideration of norms laid down by Right to Education(RTE) Act,2009.

1. There will be no external evaluation/assessment in the elementary stage of education.
2. Evaluation will be school based and will be a part of regular teaching-learning process. The schools, on their own will divide the entire course/lessons of all subjects for each class into four parts. The teachers of the school will themselves prepare and administer the tools/materials for the evaluation. The tools/materials should be developed on the basis of completion of subject-wise course/lessons. The evaluation will be based on observation, project work, discussion, oral or written work, experiments, field trips, group work and other activities.

Records of such assessment shall be maintained for each child individually.

3. Evaluation will be Continuous and Comprehensive. Continuous evaluation for each subject shall be carried out after each lesson/unit during the period of classroom transactional process. For comprehensive assessment/evaluation four term periodical/term-and evaluation shall be conducted as follows-

First term-January, February, March & April

Second Term-April, May & June

Third Term-August, September & October

Fourth Term- October, November & December

The evaluation may be conducted as per convenience or as mentioned in the academic calendar.

4. The scholastic evaluation in Lower Primary stage shall be upon Language, Mathematics, English, Environmental Studies, Art. The scholastic evaluation in Upper Primary stage shall be upon Language, Mathematics, English, Social Science, Science, Art, Hindi and other prescribed classical subjects.

Assessment of scholastic area will be in numerical marks.

5. The Co-scholastic evaluation shall be upon physical education, health education, work education and environmental education in terms of development of social and personal skills, thinking skills, emotional skills, attitudes and values, scientific attitude, creative and literary skills, aesthetic sense and other competencies.

Social and personal skills shall pertain to civic sense, co-operation, tolerance, emotional stability, responsibility, respect for manual works, cleanliness, truthfulness, regularity, punctuality, discipline, leadership, appreciation of good qualities and other desired aspects.

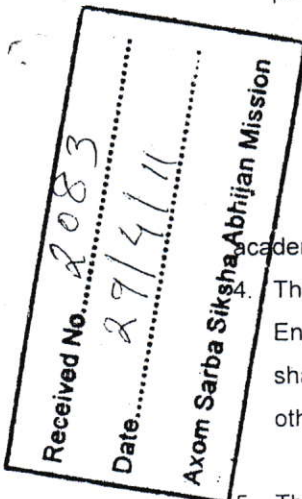
Assessment of Co-scholastic areas will be in Grade as follows-

Grade 'A'= 80%-100%

Grade 'B'= 60%-79%

Grade 'C'= 40%-59%

Grade 'D'= below 40%



6. For the student who could not perform up to the satisfactory level i.e. who have obtained Grade 'D' or below 40% in the Continuous and Comprehensive Evaluation (CCE), the school authority will arrange special classes to make up their deficits within a specified time frame.


