The Meeting was chaired by the Shri S. C. Das, IAS, Additional Chief Secretary, Education Department, Assam in his office chamber.

At the outset, the Chairman welcomed all the members present and asked Deputy Secretary to apprise the relevant provision of the RTE Act, 2009. Sri P. Lahon, Deputy Secretary, Elementary Education Department briefed the provision of section 12 of RTE Act, 2009 and Rule 7 & 8 of Assam RTE Rules, 2011. The meeting discussed in details all the provision of the relevant section & rules of the RTE Act, 2009 and Assam RTE Rules, 2011 and unanimously arrived at the following decisions :-

- 1 • To prepare a list of all private schools of all districts pertaining Elementary Education Department from class I to VIII (Action by DEE, Assam).
- 2 • To collect detail particulars of admission during the Academic year 2013 & 2014 against 25% reservation for disadvantaged and weaker section from all the private schools. Particulars in respect of total intake capacity of class-I is also to be collected (Action by DEE, Assam).
- 3 • Letters to all Schools to be issued informing the publication of notification regarding 25% reservation & notification of disadvantage groups and asking them for implementation of the provision of section 12 RTE Act, 2009. (Action Mission Director, SSA).
- 4 • A proforma is to be designed to collect the information & particulars of all private schools for re-imbusement of per child expenditure. (Action jointly Director of Elementary Education, Assam & Deputy Secretary, Elementary Education).
- 5 • The Expenditure per child in Govt. Elementary Schools will be calculated for the year 2014-15. (Action DEE).

It was decided to complete the action within one week of time.
The meeting ended with vote of thanks from the chair.
