NOTIFICATION

Dated Dispur the 8th March'2017

PNA 627/2010/418 : In exercise of the powers conferred by section 38 of the Right of Children to Free and Compulsory Education Act, 2009, (Act No. 35 of 2009), the Governor of Assam hereby notified to make the following rules further to amend the Assam Right of Children to Free and Compulsory Education Rules, 2011 herein after referred to as the Principal Rules namely:-

- Subject title and commencement : 1. (1) These rules may be called the Assam Right of Children to Free and Compulsory Education (ARTE) (Amendment), Rules , 2017.
- (2) They shall come into force on the date of their Publication in the official Gazette.
- Amendment of Rule 13 2. In the Principal Rules, in rule 13, in sub rule (1),-
- (i) for the existing clause (ii), the following shall be substituted, namely:-
“(ii) Twelve members shall be from parents or guardians of the students of the school in the following manner:-”
- (ii) In clause (ii) for the existing sub-clause (a), the following shall be substituted, namely:-
“(a) Among parent/guardian members, six shall be from disadvantaged groups or weaker section and one of them shall be from parent/guardians of children with Special Needs (if any) in the school;”
